### Types of Permits

#### ANNUAL LAND ACCESS PERMIT (AL)

Includes annual <u>Land Access</u> for hiking, berry picking, fishing, picnics, and bird watching for **ONE household**. All names of family members must be named on the permit at the time of purchase.

Alaska residents & Military \$40, non-residents \$75

#### **ANNUAL CAMPING PERMIT (AC)**

Includes annual <u>Land Access</u> and <u>Camping</u> for **ONE household**. All names of family members must be named on the permit at the time of purchase. Camping is limited to 7 consecutive days in one location per stay. \$120 per family

#### **ANNUAL SMALL GAME HUNTING PERMIT (SG)**

Includes annual <u>Land Access</u> & <u>Small Game</u> <u>Hunting</u> for hares, waterfowl, upland game birds. A Small Game hunting permit must be purchased separately for anyone over the age of 16.

Alaska residents & \*Military \$75, non-residents \$100

#### ANNUAL DEER HUNTING PERMIT (DH)

Includes annual <u>Land Access</u>, <u>Camping</u> & <u>Hunting</u> for Deer. A Deer Hunting permit must be purchased separately for anyone over the age of 16.

Alaska residents & \*Military \$200, non-residents \$250

#### **ANNUAL BEAR HUNTING PERMIT (BH)**

Includes annual <u>Land Access</u>, <u>Camping</u> & <u>Hunting</u> for Bear. A Bear Hunting permit must be purchased separately for anyone over the age of 16.

Alaska residents & \*Military \$800, non-residents \$1,500

### PERSONAL USE FIREWOOD (FW) – effective 4/1/25

Firewood harvesting

, per cord (4ft x 4ft x 8ft), valid for 14 days from the date of purchase.

\$40.00 per cord – Senior Citizens Exempt (1 per month)

#### 7- DAY LAND ACCESS PERMIT

Includes <u>Land Access</u> for hiking, berry picking, fishing, picnics, and bird watching for **ONE household**. **\$20.00 per household** 

#### SINGLE NIGHT CAMPING PERMIT

Includes <u>one night of camping</u> per RV, trailer and/or tent. **\$15.00 per night**

All Discounted & Exempt Permits must be obtained in-person and are required to sign a liability waiver (EVERY YEAR)

# **Permit Terms & Conditions**

- 1. Leisnoi Shareholders, their spouses, first-line descendants, and employees are exempt from permit fees on Leisnoi Lands. Spouses of employees will pay half the permit fees for hunting.
- 2. Senior Citizens (65+) who are residents of Kodiak, and Disabled Veterans with a disability rating of 50% or higher, are exempt from permit fees for Land Access and Camping permits.
- 3. Anyone receiving an exempt permit is required to sign a liability waiver on an annual basis.
- 4. Permits are only for the **CURRENT** calendar year and are non-transferable to other households. One household includes up to six household members per permit.
- 5. Hanging permits **MUST** be visible and faced outwards displaying your permit number from your registered vehicle.
- 6. Permit holders assume **full responsibility and risk** for their own safety and any accompanying minors. Parents and/or guardians must sign a waiver for all children under 16 years of age in their household.
- 7. Permission to enter and use the permit area is conditional upon your compliance with all rules and conditions. Violations of permit rules may result in denial of a future permit or the revocation of a current permit.
- 8. Please be aware UAV photographs, surveillance cameras and aerial drones may be used for the enforcement of land permit rules and regulations.
- 9. The use of maps provided by Leisnoi are for general reference only. Individuals on Leisnoi lands need to provide their own map for navigational purposes.
- 10. LEISNOI PERMITS are NOT a license to hunt or fish. Hunting and fishing licenses must be obtained through proper authorities, and Alaska Dept. of Fish & Game laws must be obeyed.
- 11. No hunting or shooting within one (1) mile of any camp, cabin, or active logging area.
- 12. Wild game processing in the field must be done in a manner that minimizes bear problems.
- 13. Camping is NOT allowed outside of the designated camping areas unless hunting.
- 14. Camping is allowed by permit only. A maximum of 7 consecutive nights per stay in one location.
- 15. Do not leave broken bottles in the fire pits or camping areas. No grey/ black water dumping.
- 16. <u>ALL TRASH MUST BE PICKED UP & TAKEN OUT! CLEAN UP YOUR CAMPING AREA</u> BEFORE LEAVING!
- 17. **NEVER LEAVE A FIRE UNATTENDED.** Make sure your fire is completely out (cold and not smoking) before leaving.
- 18. **ACTIVE REFORESTATION AREAS CLOSED TO ANY & ALL ACCESS.** Please be careful of recently planted conifer seedlings in harvested timber areas.
- 19. FIREWORKS, TRAPPING, PALLET BURNING AND CHRISTMAS TREE CUTTING ARE PROHIBITED ON ALL LEISNOI LANDS.
- 20. MOTORIZED VEHICLES INCLUDING ATVS MUST REMAIN ON IMPROVED ROADS AND IDENTIFIED EASEMENTS AND TRAILS.
- 21. **PERMITS ARE FOR PERSONAL USE ONLY!** Please contact Kodiak Office regarding commercial bear permits.

### Terms And Conditions Specific to Gathering Firewood

- Gathering firewood is only permitted in the area(s) marked on the <u>Firewood Gathering Map</u> or as instructed by Leisnoi personnel.
- ALL FIREWOOD (PER CORD) MUST BE COLLECTED WITHIN 14 DAYS FROM THE DATE THE PERMIT WAS PURCHASED.
- Any standing trees (dead or alive) are off limits and may not be cut down for firewood.
- No gathering of firewood within one hundred feet of any fish-bearing lake, stream or river.
- Do not block roads or trails with vehicles or downed wood.
- Firewood may not be gathered from any active reforestation areas.
- Please protect surrounding trees and seedlings from injury when gathering firewood.
   THESE ARE IMPORTANT FOR CHINIAK'S FUTURE FOREST!

## For your Safety & the Safety of others:


- For your personal protection, please wear leather gloves and boots, safety chaps, safety glasses, ear protection and a hard hat.
- Be careful when fueling equipment/saws to avoid gas spills. Serious explosions and disabling burns have occurred to operators restarting saws after refueling spills.
- Smoking is NOT permitted on the roads or in wood gathering areas.
- ONLY cut and split enough wood to be hauled at one time as gathered/cut wood may be collected by another permit holders.
- Please share the woods It may be unsafe and disruptive to cut firewood during hunting seasons.
- BRIGHT, FLUORESCENT COLORS SHOULD BE WORN WHILE CUTTING WOOD!
- · Vehicles must remain on roads while gathering firewood.
- BE AWARE OF BEARS! Stay alert! Look for signs of bears and make noise, so you do not surprise them. Stay calm during a bear encounter and do not run!

## **Trespass Violation Fees**

- Violation of Permit Terms and Conditions:
  - <u>First Violation</u>: Provisional Citation requiring violator(s) to purchase Annual Land Use permit within 30 days. If a permit is not obtained, a \$250 fine shall be imposed, and the violator(s) will be reported to the Alaska State Troopers as a Criminal Trespass complaint.
  - <u>Second Violation:</u> Citation requiring violator(s) to purchase Annual Land Use permit within 30 days. If a permit is not obtained, a \$500 fine shall be imposed, and the violator(s) will be reported to the Alaska State Troopers as a Criminal Trespass complaint.
- Violations of permit rules may also result in denial of future permits or the revocation of a current permit.

## Commercial Activity is PROHIBITED on Leisnoi Lands

This includes but is not limited to the following activities: Renting RV and Campers on Leisnoi Lands, commercially guided hunting and tours, or the sale of gathered firewood. Commercially guided hunting is by special permit/permission only. Anyone found conducting commercial activity on Leisnoi Lands without permission will have their permit(s) revoked, may be trespassed, and permanently barred from Leisnoi Lands.
